

The course will be conducted using the e-learning method

The training materials will be posted on the course website (moodle educational platform). Completion of the course will be done through online quizzes. Purpose of education: the aim of the course is to systematize the knowledge covered by the course program. Learning content for individual learning activities will be available after logging in to the course website.

Graduates will receive a certificate of completion of the course signed by the director, pursuant to § 16 it. 2 of the Regulation of the Minister of National Education of March 19, 2019 on continuing education in non-school forms (Journal of Laws, item 652).

The aim of the training is to provide participants with knowledge about the organization of documentation as part of providing psychological and pedagogical assistance to students with special educational needs.

The provisions of the educational law concerning the education of students with special educational needs indicate the need to provide individual groups of students with psychological and pedagogical assistance adequate to their needs. In the case of students with a certificate of the need for special education, teachers are required to prepare a multidisciplinary assessment of the student's functioning level, and then an individual educational and therapeutic program based on it.

With regard to students with an opinion from PPP, a school / preschool institution is obliged to ensure the implementation of the recommendations included in the opinion.

By participating in the training, you will learn how to correctly construct an IPET, what content it should contain and how to develop a multi-specialist assessment of the student's functioning level. In addition, you will learn what other documents are worth having when organizing psychological and pedagogical assistance for students with SEN (summary tables, information sheets, contracts, evaluation of the effectiveness of activities undertaken as part of psychological and pedagogical assistance).

The training is aimed at teachers, special educators, therapists and school educators.
